All uses of the trademarks “MailWraps”, “Yard DeSigns”, or “BreezeArt” must be accompanied by the ® registered trademark designation. All uses of the trademark “MatMates” must be accompanied by the ™ trademark designation. These trademarks and words may not be used in any way except to sell the respective products manufactured by Magnet Works, Ltd.
